1 <u>RULES</u>

- 1.1 The event will be governed by the rules as defined in the World Sailing Racing Rules of Sailing (RRS 2021-2024)
- 1.2 In all rules governing this event, the notations;
- 1.2.1 [DP] denotes a rule for which the penalty is at the discretion of the jury and may be less than a disqualification.
- 1.2.2 [SP] denotes a rule for which a standard penalty may be applied by the race committee or technical committee without a hearing or a discretionary penalty applied by the jury with a hearing. This changes RRS 63.1 and A5.1.
- 1.2.3 [NP] denotes a rule that shall not be grounds for protests by a boat. This changes RRS 60.1(a) and 63.1.
- 1.3 National prescriptions if any will apply.
- 1.4 All Indian competitors registered under the YAI, shall comply with the National Code against Age Fraud in Sports (NCAAFS)
- 1.5 If there is a conflict between languages, the English text takes precedence.
- 1.6 If there is a conflict between the Notice of Race (NOR) and the Sailing Instructions (SI), the SI takes precedence.
- 1.7 [DP] [NP] All prevailing Central and State Government SOPs and protocols with regards to <u>COVID -19</u> shall be strictly adhered to by all personnel when ashore. All such instructions will be prominently displayed on the Notice Board.

2 <u>ADVERTISING</u>

- 2.1 [DP] [NP] Boats and sails may be required to display advertisement chosen and supplied by the organizing authority. ISAF Regulation 20 9.2 'Advertising Code' shall apply.
- 2.2 Competitors may also be required to wear a vest carrying event sponsors names and logos at all times while afloat.
- 2.3 All competitors and their support team automatically grant the organizing authority and any event sponsors, the right in perpetuity to make, use and show at their discretion any motion pictures and live, taped or filmed television and other reproductions of them made at the venue, until their final departure, without compensation. Competitors may be required for media interviews during the period of the event.
- 2.4 Boats may be required to carry cameras, sound equipment or positioning equipment as specified by the organizing authority. Information from such equipment shall not be used by a boat as evidence in a hearing. This changes RRS 63.6.
- 2.5 [DP] The equipment provided, once placed on the boat as instructed by the organizing authority, shall not be manipulated by the competitor or the support person in any way, except when so required by the organizing authority.



3 <u>CLASSES AND DIVISIONS</u>

3.1 The event will be organized in the following classes listed in the table below

3.2 A minimum of 3 competitors are required to constitute a division as provide in 3.1(except for girls category).

4 <u>RANKING EVENT</u>

- 4.1 The event approved by the YAI will be considered as one of the ranking events for Optimist Main, ILCA 4, ILCA 6 Youth, 29er, 420, RS One.
- 4.2 This event is a PKA approved Ranking Event for Kiteboarding (Men/Women)

5 <u>ELIGIBILITY AND ENTRY</u>

- 5.1 All entries shall meet the requirements of WS Regulation 19: Eligibility Code.
- 5.2 All participants in the Ranking Classes are required to be Life Member/Annual Associate Member of YAI.
- 5.3 Entries will be made by filling the entry form and indemnity bond provided at the end of this NOR.
- 5.4 Competitors and support staff are requested to send the Entry Forms by email before the last date for entry to: trishnayachtclub1977@gmail.com
- 5.5 Competitors and their support staff shall complete onsite registration. The necessary documents for onsite registration are as follows:-

Original Entry Form duly completed

- <u>**Copy of Birth Certificate**</u> as proof of age for Youth, Junior and Sub Junior categories.
- Indemnity Bond for those under the age of 18.
- Guardian Authority Letter will be mandatory for registration of minors who are attending the event without their parents.
- YAI Membership Card details of the sailors concerned.
- <u>**Two Passport Size Photos**</u> of the competitor and support staffs.
- 5.6 Documents required for registration of coaches/support persons: Original Coach Entry Form duly completed

- 6.3 Entry fee may be paid in advance by online transfer along with the entry form through email. In case of payment by Cheque or DD, the same must reach the organizing authority before the deadline given above.
- 6.4 Late fee will be applicable for late registrations after 0001 H on 21 Jul 2022.
- 6.5 Late registration will take place in the Regatta Office at Backwaters, KRS Dam, Mandya.
- 6.6 The competitors who wish to make the payment upon arrival may confirm entries with all details by email to <u>trishnayachtclub1977@gmail.com</u> before 20 Jul 2022 and they will not face any levy of the late fee provided all entries committed are paid for the club on arrival.
- 6.6 Any entry, if cancelled, the entry fee will be refunded as follows:-

7 <u>RACE FORMAT</u>

- 7.1 The Championship shall be a single discipline, fleet racing format.
- 7.2 Men, women, boys and girls may race together, even as positions for different categories may be extracted and be scored separately.
- 7.3 In the event, any sailor can participate in both Rigs of ILCA 4 & ILCA 6 as the races will be conducted in alternate sessions.
- 7.4 For all classes and divisions, participants shall race a maximum of 4 races per day, in a maximum 12 race series. Five races are required to validate the championship for each division.

8.1 No warning signal will be displayed after 1400 hrs on 13 August 2022.

8.2 The Official arrival day is 07 Aug 2022. However teams wanting to practice prior to the event may arrive on or after 20 Jul 2022 with prior permission from org secretary.

9 <u>MEASUREMENT/EQUIPMENT INSPECTION</u>

- 9.1 All boats will be inspected for class rules compliance prior to racing as per schedule mentioned on Notice Board.
- 9.2 Equipment Inspection Form will be emailed to competitors and also will be available at the Race Office. The form has to be duly filled and presented to the Equipment Inspector at the time of Inspection. Registration will be considered as complete ONLY after Equipment Inspection has been passed by the Technical Committee.
- 9.3 Additional spot measurement checks may be carried out during the Championship.
- 9.4 [DP] [NP] Equipment shall only be replaced/repaired with the written permission of the Technical Committee. Substitution of damaged or lost equipment will not be allowed unless approved by the technical committee. Requests for substitution shall be made to the technical committee at the first reasonable opportunity, which may be after the races.
- 9.5 International 420 Class of boats should produce a Measurement Certificate
- 9.6 All Classes of Hull/Board Should have ISAF/WS Plaque or Sticker. All Sails, Spars and Foils should be class legal.
- 9.7 [DP] [NP] Unless authorised otherwise by the organizers, boats and equipment shall be stored, launched and retrieved from the designated area at the event site.



10 SAILING INSTRUCTIONS

The Sailing Instructions (SI) will be available upon registration. Any changes to the SI shall be displayed on the Official Notice Board.

11 <u>COURSES</u>

Courses will be as described in the Sailing Instructions.

12 <u>SCORING</u>

Scoring will be according to the Low Point System of RRS Appendix A as amended below:-

- (a) Five (05) races are required to be completed to constitute a series for all categories.
- (b) When six or fewer than six (06) races have been completed, a boat's series score will be the total of her race scores.
- (c) When seven (07) or more races but less than eleven (11) races have been completed a boat's series score will be the total of her race scores excluding her worst score.
- (d) When eleven (11) or more races have been completed a boat's series score will be the total of her race scores excluding her two worst score.

13 <u>SUPPORT VESSELS</u>

- 13.1 Support Vessels shall be registered at the Race Office. No Support Vessel or Coach Vessel shall be allowed in the racing area during the races.
- 13.2 Support Vessel shall display their respective Club flag/white flag bearing the name of the club whose boat they are supporting. No other flags or identification shall be displayed by the support vessels.

14 <u>SAFETY</u>

14.1 Every competitor and support boat crew member shall wear a certified personal flotation device. Harness is not a personal flotation device.

RISK STATEMENT

Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. Competitors and support persons participate in the event entirely at their own risk. RRS 3 states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone." By taking part in the event, each competitor agrees and acknowledges that:

They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;

They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;

They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;

By participating in any race, they are satisfied that their boat is in good order, complies with the class rules, is equipped to sail in the event and they are fit to participate;

The provision of a race management team, rescue vessels, jury and other officials and volunteers by the organizer does not relieve them of their own responsibilities;

The provision of rescue vessels cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances.

It is their responsibility to familiarize themselves with any risks specific to this venue or this event drawn to their attention in any rules and information produced for the venue or event and to attend any safety briefing held for the event.
